Mr Fong holds units in CLCT through a nominee account with DBS Nominees (Private) Limited (DNPL). DNPL informed Mr Fong on 13 Jan 2021 that due to DNPL oversight it did not take up his provisional allotment of 5,437 new units in CLCT (then known as CapitalLand Retail China Trust (CRCT) (Entitlement) pursuant to the preferential offering undertaken by CRCT on 30 Nov 2020 (Preferential Offering). Accordingly, the Entitlement has lapsed on 8 Dec 2020, being the closing date for acceptance of the Entitlement.
